1 Title

This order is the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022 Amendment Order (No 2) 2022.

2 Commencement

This order comes into force on 22 July 2022.

3 Principal order

This order amends the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022.

4 Clause 2 amended (Commencement)

In clause 2(2), replace “16 August 2022” with “1 February 2023”.

5 Clause 4 amended (Temporary suspension and reduction of current rate of excise duty and excise-equivalent duty on motor spirits)

In clause 4(1), replace “15 August 2022” with “31 January 2023”.

6 Clause 5 amended (Current rates of excise duty and excise-equivalent duty on motor spirits reinstated on 16 August 2022)

In the clause 5 heading, replace “16 August 2022” with “1 February 2023”.

Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022 Amendment Order (No 2) 2022

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 22 July 2022, amends the Excise and Excise-equivalent Duties Table (Temporary Reduction of Motor Spirits Duty) Amendment Order 2022 to extend the temporary reduction of motor spirits duty until 31 January 2023, with full rates returning on 1 February 2023.

This order is a confirmable instrument under section 122 of the Legislation Act 2019. It is revoked at the close of 31 December 2023, unless confirmed earlier by an Act of Parliament. That stated time is the applicable deadline under section 121 of that Act.
