Email notifications for DTR movements

- Background

- When submitting an ICR message with a DTR request 2x email notification will be received, 1x issued by MPI and 1x issued by NZCS.
- Email notifications will be sent to the:
 - Goods location – the location where the container/cargo is currently located
 - Transit destination – the location that the container/cargo is requested to be transferred to on the DTR
 - Submitter – The submitter of the ICR lodgement with the DTR
 - Delivery Notify parties – Any delivery notify parties that the submitter of the ICR message have entered under the 'Delivery Notify Party' fields.

- Purpose

- Provide examples of DTR email notifications
- Show the key elements in the email notification
- Describe what actions should be taken when reading the emails

Key Concepts

1. The same information on the email is also sent as Business to Business (B2B) messaging.
2. 2x email notifications will be received – 1x MPI and 1x NZCS
3. Although these are received at the same time one is always sent before the other. It may be that the NZCS email arrives first then followed by the MPI email or vice versa.
4. The second email received will have the completed movement directions for both agencies
5. Both agency's must respond with a Domestic Transshipment Approved (DTA) in order to allow the container/cargo to move.
6. The email format is slightly different for the submitter of the ICR with DTR from that received by the Location of Goods and Transit Destination facilities.
7. An MPI Lodgement Status and Directions document is will be accessible via the MPI email either through a link (on the submitter notification) or as an attached PDF (on the Location of Goods/Transit Destination notification).
8. If MPI respond with a 'HELD' movement response then the message has been directed to MPI for manual processing. Once processed, MPI will issue a response that will update the movement status to DTA and the MPI lodgements status and directions attached/linked to the MPI email should be viewed and directions followed.

Identifying MPI and NZCS Emails

At the top of the email there will be text showing which agency has sent the email notification

7	Container and packaging - Shows the container number and packaging details relating to the consignment number
